However, at times Federal supervisors are faced with employees whose performance is not acceptable. This purpose of this book, *Addressing and Resolving Poor Performance: A Guide for Supervisors*, is to help you address and resolve poor performance. You should also be aware that most agencies have specific procedures and requirements that must be followed, whether they are part of a negotiated bargaining agreement or other internal agency regulation.
